COVID-19:

- By attending or participating in this competition, athletes voluntarily assume all risks associated with exposure to COVID-19 and forever hold harmless USA Swimming, South Texas Swimming, Inc. (STSI), the Alamo Area Aquatic Association (AAAA), the North East Independent School District, and all meet officials from any liability or claims including for personal injuries, death, disease or property loss; including, but not limited to claims of negligence and give up any claims they may have to seek damages; whether known or unknown, foreseen or unforeseen, in connection with exposure, infection, and/or spread of COVID-19 related to participation in this competition.**

COVID-19

Screening Symptoms:

- Cough
- Chills with repeated shaking
- Muscle Pain
- Shortness of breath
- Headache
- Sore throat
- Loss of taste and / or smell
- Diarrhea
- Fever greater than 99.9 degrees
- Known contact with a person who is lab-confirmed to have COVID-19

Facility: •The Bill Walker Pool opened in October of 2019 and is part of the North East School District's Blossom Athletic Center and is also known as the North East Stadium

- It is an indoor, 10-lane facility with off-deck spectator seating for 800
- The course has been professionally certified IAW Article 104.2.2C(4) and the data is on file with USA Swimming.
- This competition will be conducted in the **SOUTH** ↓ 25-yard Pool
- 2.25-meters (7.5-ft) wide lanes
- Water depth** ↓:
 - One-meter from start end 2.35m (7.7ft) •Five-meters from start end 2.41m (7.9ft)
 - One-meter from turn end 1.77m (5.8ft) •Five-meters from turn end 1.77m (5.8ft)
- All automatic starting and timing with full digital scoreboard
- Strobe on each starting block
- Sixteen (16) adjacent lanes for warm-ups and cool downs
- Ample deck seating for athletes and coaches.



- Concessions and swim shop in the Davis Natatorium lobby
- Orientation:
 - The **NORTH** ↑ Pool backs up to the Piper-Bass Student Center
 - The **SOUTH** ↓ Pool backs up to the Davis Natatorium and has the full-motion scoreboard

- Diving:**
- Diving competition will be consolidated for UIL Districts 18-5A, 25-6A, 26-5A and 26-6A on Thursday, January 20th
 - Davis Natatorium: Warm-ups at 1600 – Competition begins at 1800
 - Preliminaries AND Finals
 - 11 dive format
 - One-meter board only
 - Five (5) voluntary and six (6) optional dives must be performed
 - All divers must be entered into this meet with their School Team via HY-TEK Commlink File AND completed Diving Sheets via www.cleanentries.com by 1200, Tuesday, January 25 2022
 - ALL DIVERS MUST BE ENTERED INTO BOTH HY-TEK AND CLEAN ENTRIES IN ORDER TO PARTICIPATE IN THIS MEET – THERE CAN BE NO EXCEPTIONS!
 - All corrections, revisions or deletions must be competed in writing and in the hands of the Diving Referee before the scheduled start of competition
 - Diving awards will be presented following the Girl’s and Boy’s Diving Championships on January 20th

- Rules:**
- The 2021 – 2022 National Federation Swimming and Diving Rules will govern this meet

Facility Rules, Regulations

- and Policies:**
- Deck changing is prohibited
 - Two-piece swim wear is prohibited
 - The presence of cell phones, smart phones, iPads, etc. anywhere behind the starting blocks is prohibited at all times during competition
 - Violators are subject to having their devices temporarily confiscated
 - Photographers and videographers are specifically prohibited from the area immediately behind the starting blocks during competition
 - Parents and other spectators are not permitted on-deck at any time for any reason
 - Flash photography of any sort is expressly forbidden during competition
 - Times noted on the scoreboard are never official and must not ever be regarded as such
 - All swimmers and divers are required to wear their approved uniforms and warm-ups
 - Hats, body or face painting, costumes, and / or props will not be allowed
 - Organized cheers by school’s teams will be allowed on deck in front of the designated seating area for each school
 - All spirit groups and Team Mascots must stay in the spectator area and will not be allowed on deck
 - Athletes and / or teams that violate these rules will be subject to disciplinary actions that could include disqualification from the competition.

Spectator Clear

- Bag Policy:**
- Please review the graphic on page four (4)

Cell phone

- Restrictions:**
- The presence and / or use of cell phones, and / or any other equipment capable of producing audio recordings, photographic or video images in locker rooms, rest rooms, changing areas or anywhere behind the starting blocks is strictly and specifically prohibited at all times
 - There are no exceptions to this prohibition
 - Violators are subject to disqualification from the meet, disbarment from the facility and arrest

Swimmer Photographs And Videos:

- There may be one or more photographers and / or videographers on deck at this meet.
- Each participating school is allowed two photographers / videographers on deck during competition.
- In the event such personnel are present, parents or guardians of swimmers under the age of 18 who do not wish to have photos or videos of their athletes made, are required to contact the Meet Director prior to the beginning of warm-ups.
- Photographers and videographers are prohibited from the area immediately behind the starting blocks, and are also specifically prohibited from taking shots using flash during the start phase of any race.

Media Deck

- Access:**
- Access to the deck by the media is carefully controlled and members must pick up the necessary credentials from the front office at the Davis Natatorium
 - A signature will be required and the credentials must be returned to that same office on departure

Format:

- Timed finals
- Nominal 60 seconds between races
- 15-minute break after the 50-yard freestyle
- 10-minute breaks after the men’s 200-yard medley relay, men’s 500-yard freestyle and the 100-yard breaststrokes

Entry

- Restrictions:**
- Each swimmer may enter four events, no more than two of which may be individual events
 - No school may enter more than four swimmers in any single individual event
 - Each school is limited to one relay team per relay event



- Relays:**
- Only the four (4) swimmers declared on the front of the relay card are permitted to report to the blocks and compete
 - If the swimmers are to be correctly noted in the Final Results, the order of swimming must also be specified.
 - Relay cards for the 200-yard Medley Relay must be turned in to the Official Scorer not later than thirty (30) minutes prior to the scheduled start of the meet.
 - Relay cards for the 200-yard Free Relay must be turned in to the Official Scorer not later than the start of the men’s 500-yard freestyle.
 - Relay cards for the 400-yard Free Relay must be turned in to the Official Scorer not later than the start of the men’s 100-yard backstroke.
 - Once relay cards have been turned in to the Official Scorer, no changes will be permitted and post-meet corrections or revisions cannot be made.

National Time

- Verification:**
- This meet has been approved by USA Swimming for NTV purposes, which means times achieved by properly registered and entered USA Swimming athletes can be loaded into the SWIMS National Database**
 - In order for a time from a high school championship or season culminating meet to be entered into the USA Swimming (USA-S) National SWIMS Database, the athlete must be currently (2020) registered with USA-S – **AND** – the athlete’s USA Swimming ID Number and legal name must be completely and accurately entered into the District 26-5A Championship Meet Manager Database
 - If done correctly, no further action by either the coach or the athlete is necessary
 - ALL swims involving the backstroke, butterfly and breaststroke will be observed by USA Swimming Certified Officials and exceptions to the technical rules will be noted to the NTV Officer on deck

Entry

- Deadline:**
- 1200, Tuesday, January 25, 2022 (No exceptions!)
 - No late and / or deck entries will be permitted

Entry Procedures

- Entries may be submitted ONLY by Hy-Tek Commlink file
- Hard copy must accompany
- Each entry must include the swimmer’s full name, swimmers school affiliation grade, and a seedtime
- Entries received without a seedtime will be rejected

Advancers:

- The four (4) top finishing individual swimmers and relay teams from each event will advance to the UIL Region VIII Class 5-A Championships in this same facility, Girls on February 4th and Boys on February 6th, 2021

Scratch

- Rules:**
- High School Championship, timed final format
 - Scratches are not permitted
 - Swimmers who fail to appear for any competition which they have entered will be disqualified from further competition
 - Previous performances will not be nullified
 - Failures to compete by reason of illness or injury are excepted.
 - An individual swimmer or relay team may withdraw from competition without penalty in any given event by declaring a false start
 - Declared false starts, however, do count as an event

Special Note:

- All officials must be properly registered with Arbiter Sports for the 2020- - 2021 Season and have passed the current exam
- Officials not currently registered are not covered by NFHS Insurance and will not be assigned
- The Meet Referee will make all deck assignments BEFORE the meet
- Therefore, all swimming officials who desire to be assigned to deck positions MUST notify the Meet Referee of their intentions and availability NOT LATER than 1800, Sunday, January 16th

- You WILL NOT be pre-assigned if your commitment and information are not submitted or not received by the deadline
- Uniforms for deck officials will be as follows:
 - White collared shirts / blouses over khaki pants, skirts, Bermuda-length shorts or capris (NO JEANS OR FLIP-FLOPS PLEASE)

PROHIBITED ITEMS INCLUDE, BUT ARE NOT LIMITED TO:

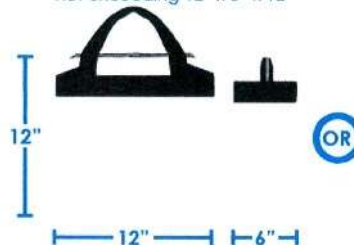
- All purses, bags or containers larger than a small clutch bag

not exceeding 12" x 6" x 12"

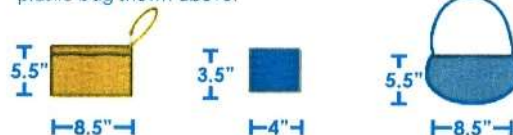
PLASTIC STORAGE BAG

Approximately the size of your hand, but absolutely no larger than 5.5" x 8.5" (see our small guide sheet) with or without a handle or strap. Can be carried separately or within an approved plastic bag shown above.
