- COVID-19:**

USA Swimming, Inc., cannot prevent you (or your child(ren)) from becoming exposed to, contracting, or spreading COVID-19 while participating in USA Swimming sanctioned events. It is not possible to prevent against the presence of the disease.
 - Therefore, if athletes choose to participate in a USA Swimming sanctioned event, they may be exposing themselves to and/or increasing your risk of contracting or spreading COVID-19.
 - **By attending or participating in this competition, athletes voluntarily assume all risks associated with exposure to COVID-19 and forever hold harmless USA Swimming, South Texas Swimming, Inc. (STSI), the Alamo Area Aquatic Association (AAAA), the North East Independent School District, and all meet officials from any liability or claims including for personal injuries, death, disease or property loss; including, but not limited to claims of negligence and give up any claims they may have to seek damages; whether known or unknown, foreseen or unforeseen, in connection with exposure, infection, and/or spread of COVID-19 related to participation in this competition.**
- COVID-19 Screening Symptoms:**
 - Cough
 - Chills with repeated shaking
 - Muscle Pain
 - Shortness of breath
 - Headache
 - Sore throat
 - Loss of taste and / or smell
 - Diarrhea
 - Fever greater than 99.9 degrees
 - Known contact with a person who is lab-confirmed to have COVID-19
- Facility:**
 - The Bill Walker Pool opened in October of 2019 and is part of the North East School District's Blossom Athletic Center and is also known as the North East Stadium
 - It is an indoor, 10-lane facility with off-deck spectator seating for 800
 - In its several configurations there may be two (2) 25-yard (SCY) racing courses, one 25-meter (SCM) racing course, or one 50-meter (LCM) racing course
 - Each of the possible racing courses has been professionally certified IAW Article 104.2.2C(4) and the data on file with USA Swimming.
 - This competition will be conducted in the **SOUTH** ↓ 25-yard Pool
 - 2.25-meters (7.5-ft) wide lanes



- Water depth:
 - One-meter from start end 2.35m (7.7ft)
 - One-meter from turn end 1.77m (5.8ft)
 - Five-meters from start end 2.41m (7.9ft)
 - Five-meters from turn end 1.77m (5.8ft)
- All automatic starting and timing with full digital scoreboard
- Strobe on each starting block
- Sixteen (16) adjacent lanes for warm-ups and cool downs
- Ample deck seating for athletes and coaches.
- Concessions and swim shop in the Davis Natatorium lobby
- Orientation:
 - The **NORTH** ↑ Pool backs up to the Piper-Bass Student Center
 - The **SOUTH** ↓ Pool backs up to the Davis Natatorium and has the full-motion scoreboard

- Diving:**
- Diving competition will be consolidated for UIL Districts 18-5A, 25-6A, 26-5A and 26-6A on Thursday, January 20th
 - Davis Natatorium: Warm-ups at 1600 – Competition begins at 1800
 - Preliminaries AND Finals
 - 11 dive format
 - One-meter board only
 - Five (5) voluntary and six (6) optional dives must be performed
 - All divers must be entered into this meet with their School Team via HY-TEK Commlink File **AND** completed Diving Sheets via www.cleanentries.com by 1200, Monday, January 18, 2021
 - ALL DIVERS MUST BE ENTERED INTO BOTH HY-TEK **AND** CLEAN ENTRIES IN ORDER TO PARTICIPATE IN THIS MEET – THERE CAN BE NO EXCEPTIONS!
 - All corrections, revisions or deletions must be competed in writing and in the hands of the Diving Referee before the scheduled start of competition
 - Diving awards will be presented following the Girls and Boys Diving Championships on January 20th

- Rules:**
- The 2021 – 2022 National Federation Swimming and Diving Rules will govern this meet

Facility Rules, Regulations

- and Policies:**
- Athletes please self-screen for COVID symptoms before leaving home
 - Self-isolate if positive
 - The Competition Protocols and Procedures, posted throughout the facility, must be followed at all times
 - Masks must be worn at all times when not in the water
 - Deck changing is prohibited
 - Two-piece swim wear is prohibited
 - The presence of cell phones, smart phones, iPads, etc. anywhere behind the starting blocks is prohibited at all times during competition
 - Violators are subject to having their devices temporarily confiscated
 - Photographers and videographers are specifically prohibited from the area immediately behind the starting blocks during competition
 - Parents and other spectators are not permitted on-deck at any time for any reason
 - Flash photography of any sort is expressly forbidden during competition
 - Standing in front of and / or leaning against the glass rails is expressly forbidden
 - Times noted on the scoreboard are never official and must not ever be regarded as such
 - All swimmers and divers are required to wear their approved uniforms and warm-ups
 - Hats, body or face painting, costumes, and / or props will not be allowed
 - Organized cheers by school's teams will be allowed on deck in front of the designated seating area for each school
 - All spirit groups and Team Mascots must stay in the spectator area and will not be allowed on deck
 - Athletes and / or teams that violate these rules will be subject to disciplinary actions that could include disqualification from the competition.

Cell phone

- Restrictions:**
- The presence and / or use of cell phones, and / or any other equipment capable of producing audio recordings, photographic or video images in locker rooms, rest rooms, changing areas or anywhere behind the starting blocks is strictly and specifically prohibited at all times
 - There are no exceptions to this prohibition
 - Violators are subject to disqualification from the meet, disbarment from the facility and arrest

Swimmer Photographs And Videos:

- Each participating school is allowed one photographer on deck during competition – mask required
- In the event such personnel are present, parents or guardians of swimmers under the age of 18 who do not wish to have photos or videos of their athletes made, are required to contact the Meet Director prior to the beginning of warm-ups.
- Photographers and videographers are prohibited from the area immediately behind the starting blocks, and are also specifically prohibited from taking shots using flash during the start phase of any race.



Media Deck

- Access:**
- Access to the deck by the media is carefully controlled and members must pick up the necessary credentials from the front office at the Davis Natatorium
 - A signature will be required and the credentials must be returned to that same office on departure

- Format:**
- Timed finals
 - Nominal 60 seconds between races

Entry

- Restrictions:**
- Each swimmer may enter four events, no more than two of which may be individual events
 - No school may enter more than four swimmers in any single individual event
 - Each school is limited to one relay team per relay event

- Relays:**
- Only the four (4) swimmers declared on the front of the relay card are permitted to report to the blocks and compete
 - If the swimmers are to be correctly noted in the Final Results, the order of swimming must also be specified.
 - Relay cards for the 200-yard Medley Relay must be turned in to the Official Scorer not later than thirty (30) minutes prior to the scheduled start of the meet.
 - Relay cards for the 200-yard Free Relay must be turned in to the Official Scorer not later than the start of the men's 500-yard freestyle.
 - Relay cards for the 400-yard Free Relay must be turned in to the Official Scorer not later than the start of the men's 100-yard backstroke.
 - Once relay cards have been turned in to the Official Scorer, no changes will be permitted and post-meet corrections or revisions cannot be made.

National Time

- Verification:**
- **This meet has been approved by USA Swimming for NTV purposes, which means times achieved by properly registered and entered USA Swimming athletes can be loaded into the SWIMS National Database**
 - In order for a time from a high school championship or season culminating meet to be entered into the USA Swimming (USA-S) National SWIMS Database, the athlete must be currently (2021) registered with USA-S – **AND** – the athlete's USA Swimming ID Number and legal name must be completely and accurately entered into the District 26-6A Championship Meet Manager Database
 - If done correctly, no further action by either the coach or the athlete is necessary
 - ALL swims involving the backstroke, butterfly and breaststroke will be observed by USA Swimming Certified Officials and exceptions to the technical rules will be noted to the NTV Officer on deck

- Deadline:**
- 1200, Tuesday, January 18, 2022

Entry

- Procedures**
- Entries may be submitted ONLY by Hy-Tek Commlink file
 - Hard copy must accompany
 - Each entry must include the swimmer's full name, swimmers school affiliation grade, and a seedtime
 - Entries received without a seedtime will be rejected

- Advancers:**
- The six (6) top finishing individual swimmers, divers and relay teams from each event will advance to the UIL Region VII Class 6-A Championships

Scratch

- Rules:**
- High School Championship format
 - Scratches are not permitted
 - Swimmers who fail to appear for any competition in which they have entered will be disqualified from further competition
 - Previous performances will not be nullified
 - Failures to compete by reason of illness or injury are excepted.
 - An individual swimmer or relay team may withdraw from competition without penalty in any given event by declaring a false start
 - Declared false starts, however, do count as an event

Special Note:

- All officials must be properly registered with Arbiter Sports for the 2021 - 2022 Season and have passed the current exam
 - Officials not currently registered are not covered by NFHS Insurance and will not be assigned
- The Meet Referee will make all deck assignments BEFORE the meet
- Therefore, all officials who desire to be assigned to deck positions MUST notify the Meet Referee of their intentions and availability NOT LATER than 1800, Sunday, January 16th

- Uniforms for deck officials will be as follows:

Access:

- Athletes and Coaches are required to enter the facility via the front doors of the Davis Natatorium marked Coaches and Athletes Only!
- Officials are asked to park toward the north end of the Walker Pool and enter through the north doors marked Officials Only
